- a. IP Radio console Bids Bid were opened this morning. Radio Shop bid was \$64,419.88. Decatur Communications bid was \$171,105.00. Sharp Communications bid was \$199,975.00. Mike requested not to make a recommendation until all bids have been read through.
- **b.** Leighton/ Littleville PD We have letters from both city councils formally requesting us to dispatch for them. We are making plans to call a meeting with both departments to work on policies and procedures.
- c. NCIC/CJIS We have turned in everything requested to obtain NCIC and CJIS approval including a copy of the 911 resolution. We are now waiting on them. Both Departments have agreed to pay the bill for NCIC. Chief King inquired if NCIC can run off each console. Mike answered yes. Littleville Police Department has a key code now that we can use to run off of from each console.
 - Chief King questioned if we knew of any delays on getting this started. Mike said the only delays will be getting our people certified and waiting on NCIC approval. And meeting with both departments.
- d. Lauderdale 911/MSPD: Michael Smith and Shelley Ezekiel went to Muscle Shoals Police Department about 3 weeks ago to inquire about NCIC procedures. Brandon Brown has been eager to help us start off doing this right. Last Friday Shelley Ezekiel, Jessica Mothershed and myself went to Lauderdale 911 to see how they dispatch law enforcement. We have been doing our research. We did ask Lauderdale about issues

- they had encountered. The only issue they have had so far was two different dispatcher talking to Police Officer on the same call but that really wasn't an issue.
- e. Letter to City of Muscle Shoals To the best of my knowledge Muscle Shoals has accepted the letter. They signed the contract with Keller EMS. And today Muscle Shoals is going through Keller's trucks and are going forward.
