#### I. Call to order:

### **b.** Leighton PD/Littleville PD update:

Mr. Smith reported that the site visit for NCIC had been completed by Johnny Cantrell and that they were issued a site number. Background checks on current staff must be completed and these have been started. Background checks must be done for all new employees and repeated for all staff every 5 years. Mr. Smith reported that seven people will attend the NCIC certification class in Florence next week with others to attend in June. 911 will be able to begin services for Leighton and Littleville PDs as soon as Littleville Police Chief delivers his warrants to the 911 office. Expected start date is the week of April 14.

## c. Street Sign Cutter:

Mr. Smith notified the Board that the 911 Center's street sign cutter was broken and would not work. Rep. Johnny Mack Morrow is providing a grant to pay for its replacement.

## **d.** Surplus Old Phone Switch Equipment:

Mr. Smith informed the Board that the surplus phone equipment had been posted for sell but no one expressed interest. Mr. Jones made a motion to post the equipment on the website one more time then dispose of it if there were no takers. Mr. Kimbrough seconded this motion. All Board members voted to approve the motion.
